**FORMAL INVITATION TO REFRAIN FROM CRIMES CONCERNING  
THE INTERNATIONAL FREE PORT  
OF THE FREE TERRITORY OF TRIESTE**

Local medias have broadcast the news that on Monday, June 29th, the Mayor of Trieste, Roberto Cosolini (PD) would have publicly announced to the representatives of the city's economy and syndicates he intention, his own and of the Commissar of the Port Authority, Mr. D'Agostino, as well as of both the President of the Region, Ms. Serracchiani and of the national Director of the State Property Office, Mr. Reggi,

to sign within 15 days the official act to remove from State Property the Northern Free Port of Trieste and to transfer the property to the City, whose administration seems to have already arranged structures and procedures in order to offer on the real estate market the areas and the buildings at the earliest possible time.

It therefore follows that Mayor Cosolini and the other public officers involved in the operation are attempting, in mutual agreement, to accelerate and impose as a *fait accompli* the removal from State Property and hand over of the Northern Free Port without waiting for the Commissar of Government to issue an eventual decree of removal of the bound of use as international Free Port, and without waiting for the conclusion of the legal procedure, opened by the Free Trieste Movement, to register the ownership of the area to the “Free Territory of Trieste - international Free Port of Trieste” as established under the Treaty of Peace of Paris.

Also, the Free Trieste Movement has already warned since a long time all public officers involved, including the Commissar of Government, from carrying out their attempt to eliminate and destinate to an illegal urbanization and speculation the Northern Free Port and, as for this matter, it has already notified to them several acts and criminal complaints, which do document very punctually both the unlawful nature of the operation due to several breaches of international and Italian laws, as well as the related anti-mafia and anti-corruption questions.

Due to this, the Free Trieste Movement considers that the attempt to force the operation, as now announced by Mayor Cosolini, constitutes a very serious illegal act, typical of Italian politics, which ultimately confirms a frame of alleged offences ranging from abuse of office to *Organisation of Criminal Community*. Therefore, it formally invites the Mayor and all who have joint responsibility to immediately refrain from this action, as well as announcing that in the following days all of this will become an integration to the criminal and international complaints that have already presented against them, and it sends this preliminary communication also to the competent courts and international organizations.
