# REQUEST OF URGENT VISUAL MARKING OF THE STATE BORDER BETWEEN THE FREE TERRITORY OF TRIESTE AND THE REPUBLIC OF ITALY

The Free Trieste Movement, as representative of the legitimate interests of a relevant part of the citizens and residents of the citizens and residents of the present-day Free Territory of Trieste

## considering

that the border of State between the present-day Free Territory of Trieste and the Republic of Italy is the one established under article 4 of the Treaty of Peace with Italy in force, signed at Paris on 10 February 1947;

that the temporary civil administration of the present-day Free Territory of Trieste is still entrusted to the responsibility of the Italian Government in compliance with the Memorandum off Understanding signed in London on 5 October 1954 between the Governments of the United States, of the United Kingdom, of Yugoslavia and of Italy, in force, as confirmed also under article 7 of the bilateral Italian-Yugoslav Treaty signed at Osimo on 10 November 1975;

that this legal status of the present-day Free Territory of Trieste is confirmed to be in force by successive acts and specific documents of the United Nations Security Council, including document S/2015/809; that the provisional Italian Government did remove bot not yet restored the visible signs of demarcation of the short border of State between the entrusted Free Territory of Trieste and the Republic of Italy;

that the urgent restoration of those visible signs on the roads of all kinds and importance is necessary and appropriate to defend international and domestic legality, civil and military law and order, also in connection to the notorious problems cause by the increasing illegal trafficking of human beings and things, including traffics of weapons and drugs;

that the restoration of the visible road signs on the border between States if a duty of the temporary civil Government, a right of the State and of the citizens of the Free Territory of Trieste, as well as of the foreign citizens in transit,

#### requests

to the provisional civil Government, through the Commissar of the Government, to promptly take care to place the requested visible signs of the border between the two States at the earliest possible time, no later than 90 days for main roads and 120 days on secondary roads, along the entire border of State between the Free Territory of Trieste and the Republic of Italy, and

### reserving

in case of failure to fulfil, completely or in part, the contents of this notice, to activate all legitimate instruments, including appeals to the pertinent international Court, in defence of the rights of the State and citizens o the Free Territory of Trieste.
