The Movimento Trieste Libera – Gibanje svobodni Trst – Bewegung Freies Triest – Free Trieste Movement, represented by its current president Roberto Giurastante, with legal office in Trieste, piazza della Borsa 7, taking action as the organization representing, even as an international subject, the legitimate rights and interests of the citizens *de jure* of the current Free Territory of Trieste under the mandate of its members and of more than 20,000 signatures it has already collected for this purpose and, specifically, to address the Security Council of the United Nations, direct guarantor of the Free Territory (UNSC Resolution 16/1947), requesting the restoration of its correct, special trusteeship to defend the interests of the International Community of State as for the full, correct and undisturbed use of the international Free Port of Trieste.

following

the previous communications, last but not least that of March 6th, 2015, in Tax Proceeding No. 484/12,

makes clear

to this society, Equitalia Nord S.p.A. (07244730961) with legal office in Milano, in person of the CEO *pro tempore* and of the chief *pro tempore* of the office in Trieste,

that the continuation of any action of tax collection in the Free Territory of Trieste and charged on the citizens and enterprises of the Free Territory of Trieste on behalf of bodies of the State of Italy, under laws of the State of Italy which were not legitimately extended to the legal order of the Free Territory (see. Cassazione civile, Sezione I, sentenza 26 febbraio 1965, n. 323 - Civil Court of Cassation, Division I, Judgment No. 323 of February 26th, 1965) and for charges including portions of the Italian public debt (prohibited under article 5 of Annex X of the Treaty of Peace of Paris of February 10th, 1947), violates the instruments of international law that establish the Free Territory and the related Italian laws of ratification and execution, in force (Law No. 811/1947; Legislative Decree of the Provisional Head of State No. 1430/1952, articles No. 10, subparagraph 1 and 117, sub-paragraph 1 of Constitution of the Republic of Italy) by vitue of which those are instruments ranking higher than national law, as well as violating the rights listed in the annexed "CHARTER OF RIGHTS OF THE CITIZENS AND OF THE ENTERPRISES OF THE FREE TERRITORY OF TRIESTE".

inviting

therefore the above mentioned Equitalia Nord S.p.A., for all consequent civil and criminal responsibilities falling under its competences:

- **a)** to take into account, in self-defense, the lack of jurisdiction of the Republic of Italy over the Free Territory of Trieste, in favor of the jurisdiction of the Italian Government as temporary civil trustee under and in execution of the Memorandum of Understanding of London del 1954 and of the Treaty of Peace of Paris of 1947 both in force;
- **b)** to take into account, in self-defense, that the concession it has received to collect the taxes of the Republic of Italy, of its bodies and its national and local administrations even from the citizens *de iure* and the enterprises of the Free Territory of Trieste, as for this part, is legally null and void as it was released in spite of the lack of jurisdiction and, therefore, *a non domino*;
- c) to immediately suspend, in self-defence, the collection of taxes of the Republic of Italy, its bodies and national or local administrations from the citizens de iure and the enterprises of the Free Territory of Trieste, as these very taxes are illegal for the above mentioned, until the entrusted Italian Government takes care to rightfully establish the regime of special trusteeship, separate from the administration of the Republic of Italy even when it comes to the fiscal regime, taxation, the establishment and collection of taxes;
